



## Susan G. Scriven

March 3, 1955 - April 11, 2026

Susan G. Scriven, 71, of County Highway 155, Gloversville, passed away on Saturday, April 11, 2026, at Ellis Hospital surrounded by her family.

She was born in Gloversville on March 3, 1955, a daughter of John and Hilda Goodemote Buyce and was a 1972 graduate of Gloversville High School. Sue was an area resident until moving to Fort Wayne, Indiana in 1994. She later moved to Berlin, Connecticut, returning to Gloversville in 2016.

Mrs. Scriven, along with her late husband, Phillip, owned and operated the former Belvedere Travel Agency in Johnstown until 1990. While in Fort Wayne, Sue was employed at Miles Homes. In Berlin, she worked at its affiliate, DeGeorge Homes. When she returned to the area, she worked at the Fulton County Community Heritage Corp. in Gloversville, retiring in 2020. Sue was also an election poll worker in Indiana and locally.

She loved her feline pets and always enjoyed spending time with family and friends. Sue enjoyed helping others and was a friend to all at Petoff Garden Apartments.

In addition to her parents, she was predeceased by her husband, Phillip Scriven, who died in 2008 and her brother-in-law, Robert Kenney, who died in 1999.

Survivors include a son, Jason Malik of Northville; two step-children, Laurie (Bruce) Heberer of Johnstown and Scott Scriven of New Milford, CT; a sister, Donna Kenney of Gloversville; six grandchildren, Savannah (Todd) Cool, Elliot and Ellajay Malik, Joshua and Eric Heberer, and Wesley Scriven; three great-

grandchildren, Toddy, Theodore, and Juniper Cool; and her former husband, Richard Malik of Gloversville.
